

# terms & conditions

## OF SCHOOLTEX REWARDS

In these terms and conditions SchoolTex Rewards means benefits in the manner of loyalty payments (SchoolTex Rewards refund payments) paid back to schools registered on the SchoolTex Rewards programme, through purchases made from Postie+ on SchoolTex labelled product.

1. SchoolTex Rewards applies to the purchase of SchoolTex labelled products only.
2. SchoolTex Rewards became effective on 1st December 1999 and will remain in effect until terminated by Postie+ with 30 days written notice to the school.
3. SchoolTex Rewards operates in compliance with the 'Customer Guarantee Act' and the 'Fair Trading Act'. The rights of the school shall be those rights governed by New Zealand law in accordance with the aforementioned Acts.
4. Postie+ shall have the right at any time to delete, vary, amend, or add to the Terms and Conditions of SchoolTex Rewards.
5. If any unresolved dispute or difference shall arise between parties regarding any matter concerning the operation of SchoolTex Rewards, it may be referred to arbitration in New Zealand in accordance with the 'Arbitration Act 1908'.
6. Any information pertaining to SchoolTex Rewards for schools will be stored safely by Postie+ in accordance with the 'Privacy Act 1993'.
7. Any information that helps provide better service or benefit obtained through and for the operation of SchoolTex Rewards will be retained by Postie+ and may at any time be accessed and corrected by the customer in accordance with the 'Privacy of Information Act 1993'. Any such information will not be sold, or in any way made available to a third party. Postie+ retains the right to state the total value of commission earned by a school, for any period, either in publicity releases, in response to customer enquiries or similar. We believe this will help maximise the support for SchoolTex Rewards and the commission the school will receive.
8. Postie+ reserves the right to withhold school information at times of computer malfunction, power loss and other interruptions beyond its control, that have an effect on normal daily operations.
9. Postie+ reserves the right from time to time to make special offers to selected schools within the SchoolTex Rewards and the Postie+ direct mail database.
10. SchoolTex Rewards refund payments will be paid out to schools six monthly from commencement of programme. SchoolTex Rewards refund payments will only be paid out once refunds exceed \$50. Any funds under \$50 will be held over to the following payout period.
11. Upon registering for SchoolTex Rewards, the school agrees to supply Postie+ with a copy of its uniform list and to include Postie+ on the uniform list as a supplier.
12. A SchoolTex Rewards refund is only available on SchoolTex labelled products purchased from Postie+ retail outlets. SchoolTex Rewards refunds do not apply to Postie+ mail order or on-line purchases. SchoolTex Rewards refunds are not applied in addition to Postie+ "Bulk Sales" discounts or SchoolTex sale priced items.
13. SchoolTex garments must be purchased with the intention of being used for a specific school's uniform in order for SchoolTex Rewards to apply.
